Prometric Test Centres update

Due to the Government Level 5 restrictions all Prometric Test centres are currently closed. Please continue to submit your NQEMT Application Forms via email and they will be processed upon receipt.

PHECC are working with Prometric to accommodate candidates where possible at predetermined test centres on predetermined dates.

PHECC are now also offering online proctoring exams with Prometric. This is a reliable and valid way to test from your own PC, it is also convenient to candidates, making the testing experience as stress free as possible. This remote way of testing will give greater flexibility to choose where to test, when to test and how to test. It is a reliable, convenient, yet secure testing for candidates.

6-month exam completion deadline

MCQ Examinations are now available to be taken remotely, therefore all candidates should be able to test over the coming weeks. If you are unable to attend your NQEMT EMT exam due to cancellations because of COVID-19 restrictions, we will endeavour to accommodate you at the next available examination. If candidates are unable to secure an exam, we will accommodate candidates by extending the 6-month deadline for exam completion (if and where applicable).

Exam Viewing sessions

In accordance with Government restrictions, all viewings have now been suspended until further notice. Please continue to submit Viewing Application Forms as normal (please be advised that you cannot continue to take a repeat exam if you are awaiting a viewing appointment). We will contact you for an appointment once restrictions have been lifted.

Attendance at Exams

In line with government and HSE guidelines, if you are displaying any symptoms of COVID-19 or answer yes to any of the questions (listed below) please do not attend your appointment.

- have you had symptoms of cough, fever, high temperature sore throat, runny nose or flu like symptoms now or in the last 14 days?
- have you been confirmed or suspected of having Covid-19 in the last 14 days?
- have you been in contact with a person who has been confirmed or suspected of having Covid-19 in the last 14 days?
- have you been advised to self-isolate by a doctor?
- have you been advised to cocoon by a doctor?

You will be asked these questions again when you arrive in the PHECC for your appointment.
